**NOTICE OF EFFECTIVE DATE OF SECOND AMENDED JOINT
PLAN OF LIQUIDATION OF DEBTOR AND
OFFICIAL COMMITTEE OF UNSECURED CREDITORS**

NOTICE IS HEREBY GIVEN that, as of August 1, 2026, all conditions precedent to the effectiveness of the *Second Amended Joint Plan of Liquidation of Debtor and Official Committee of Unsecured Creditors*, dated May 18, 2026 [Dkt. No. 278] (the “*Plan*”), filed by RAS Data Services, Inc. (the “*Debtor*”) and the Official Committee of Unsecured Creditors (the “*Committee*”), and as confirmed by the *Findings of Fact, Conclusions of Law, and Order Confirming the Second Amended Joint Plan of Liquidation of Debtor and Official Committee of Unsecured Creditors* [Dkt. No. 354] (the “*Confirmation Order*”) entered by the United States Bankruptcy Court for the Northern District of Illinois (the “*Bankruptcy Court*”) on July 14, 2026, have been satisfied or waived and the Effective Date² of the Plan occurred on **August 1, 2026**.

NOTICE IS FURTHER HEREBY GIVEN that, pursuant to Section 5.1.1 of the Plan, all requests for allowance and payment of Administrative Claims (including Professional Fee Claims for services rendered prior to the Effective Date) must be filed with the Bankruptcy Court no later than the Administrative Claims Bar Date, which is thirty (30) calendar days after the Effective Date, or **August 31, 2026**. Any person or entity that fails to timely file an application for allowance and payment of an Administrative Claim by the Administrative Claims Bar Date shall be forever barred from asserting such Administrative Claim against the Debtor, its Estate, the Liquidating Trust, or Liquidating Trust Assets. Also pursuant to Section 5.1.1 of the Plan, all objections to any Administrative Claims must be filed with the Bankruptcy Court and served on all applicable parties no later than twenty-one (21) days after such application is filed.

NOTICE IS FURTHER HEREBY GIVEN that, pursuant to Section 5.5.2 of the Plan, any Holder of an Erroneous Payment Claim (as listed on Schedule 1.33 to the Plan) seeking allowance of such a claim must file a motion with the Bankruptcy Court on or before the Erroneous Payment Claims Bar Date, which is twenty-one (21) days after the Effective Date (or the next Business Day if such date does not fall on a Business Day), or **August 24, 2026**, and schedule such

motion for presentment in accordance with the Bankruptcy Court's procedures. Said motion must contain certain information identified in Section 5.5.2 of the Plan. Any Holder that fails to timely file such a motion by the Erroneous Payment Claims Bar Date shall be deemed to have unconditionally and irrevocably waived its right to assert the Erroneous Payment Claim.

NOTICE IS FURTHER HEREBY GIVEN that, pursuant to Section 7.6 of the Plan, prior to making Distributions, the Liquidating Trustee will require all Holders to furnish a Form W-9 and an OFAC/Specially Designated Nationals certification (together, the "*Pre-Distribution Certifications*"). Pre-Distribution Certification forms will be mailed (and where e-mail addresses are available, by e-mail) to each Holder (and Holder's counsel of record, if any) prior to Distributions being made, and **Holders will have thirty (30) days from the date of mailing to return the executed Pre-Distribution Certifications.** Any Holder that fails to timely return the executed Pre-Distribution Certifications within such thirty (30) day period shall be deemed to have forfeited its right to receive Distributions and shall be forever barred and enjoined from asserting any right to Distributions made prior to the Liquidating Trustee's receipt of the executed certifications.

NOTICE IS FURTHER HEREBY GIVEN that, pursuant to Section 6.2 of the Plan, all proofs of claim arising from the rejection of Executory Contracts (deemed rejected under Section 6.1 of the Plan as of the Confirmation Date) must be filed with the Bankruptcy Court no later than twenty-one (21) days after the Confirmation Date (or the next Business Day if such date does not fall on a Business Day), or **August 24, 2026.** Claims arising from the rejection of Executory Contracts pursuant to Section 6.1 of the Plan, for which the Holder thereof fails to timely file a proof of claim, shall be released, discharged, and forever barred from assertion against the Debtor, its Estate or its property, the Liquidating Trust, or Liquidating Trust Assets.

NOTICE IS FURTHER HEREBY GIVEN that the Confirmation Order and the Plan contain other provisions that may affect your rights. You may obtain a copy of the Confirmation Order and/or Plan on the Bankruptcy Court's website at <https://www.ilnb.uscourts.gov/> or upon request from counsel to the Debtor. You are encouraged to review both the Confirmation Order and the Plan in their entirety and consult with your own legal advisors.
